Post Entry : Kshs. 200/-

- OPEN TO MALE, FEMALE & JUNIOR GOLFING MEMBERS OF LIMURU COUNTRY CLUB AND GUESTS OF THE SPONSOR WITH OFFICIAL VALID HANDICAPS. MARKERS WILL BE ALLOWED AT THE CAPTAIN'S/SPONSOR'S DISCRETION.
 - THE FIRST 108 REQUESTS FOR AFTERNOON START WILL BE DRAWN ACCORDINGLY. ALL OTHERS WILL BE DRAWN TO PLAY IN THE MORNING.
 - ALL ENTRIES WILL CLOSE ON THE CLUB-NIGHT PRECEEDING THE EVENT/TOURNAMENT.
 - POST ENTRIES AT THE CAPTAIN'S DISCRETION. NO SHOWS AFTER THE DRAW WILL BE FINED DOUBLE THE ENTRY FEE AND BE SUSPENDED FROM THE NEXT TWO CLUB COMPETITIONS. THE SECOND NO-SHOW IN THE SAME MONTH WILL BE SUBJECT TO THEIR HANDICAP SUSPENDED FOR 3 MONTHS. APOLOGIES TO BE DETERMINED BY VALID REASON GIVEN TO THE COMPETITION COMMITTEE
 - NO PLAYER MAY WIN MORE THAN ONE PRIZE. PLAYERS NOT PRESENT AT PRIZE GIVING WILL FORFEIT THEIR PRIZE.(EXCLUDING LONGEST DRIVE; NEAREST TO THE PIN)
 - IN THE EVENT OF A TIE FOR ANY POSITION, THE COUNTBACK RULES WILL APPLY.
 - ALL GOLFERS TO REPORT TO STARTER 5 MINUTES BEFORE TEE TIME
 - WITHIN 5 MINUTES - TWO STROKES PENALTY
